Criminal Justice Administration - D. Mitchell - 6 hr. Take-Home (Take-Home Mode) (24)

The exam may be picked up on ANY day during the exam period. The exam must be returned to Room 203 within 6 hours, but not later than 4:00 pm

Criminal Law §2 - Bowman - 8 hr. Take-Home (Take-Home Mode) (42)

Criminal Procedure - Trachtenberg - 6 hr. (Take-Home Mode) (51)
